Staff Report

The minutes of the September 17, 2019 meeting of the CVMPO are attached for your review and approval.

Recommendation: Staff recommends approval.

4. Update on Organization Name Change & Bylaws Update (Attachment 4)

At its July meeting, the Central Virginia Metropolitan Planning Organization voted to adopt amended bylaws which included a name change to the Central Virginia Transportation Planning Organization. This new name is intended to help the public better understand the role of the organization in the region's transportation planning process.

Our partners at VDOT and the Federal Highway Administration concur with the changes, but for the amendments to take effect, our legal counsel advised that each of the five member localities needed to adopt the attached resolution. This new, simplified resolution replaces similar documents from 1979 and 2000, and allows the policy board to better govern itself in the context of current state and federal regulations.

All member localities have scheduled the resolution for consideration in the month of October:

Town of Amherst October 8
County of Amherst October 1
County of Bedford October 28
County of Campbell October 1
City of Lynchburg October 22

Once the last locality adopts the resolution on October 28, the amended bylaws will go into effect, and staff will begin the process of executing a revised Memorandum of Understanding between the Secretary of Transportation, Greater Lynchburg Transit Company, Central Virginia Planning District Commission, and Central Virginia Transportation Planning Organization.

5. Upcoming TIP Amendment: 221/501 Split Pairs Project

On September 24, staff received a request from VDOT to amend the Central Virginia Transportation Improvement Program (CVTIP) to add UPC 113116 (221/501 Split Pairs Project), which has been funded through Smart Scale. TIP amendments must be advertised with a 30-day public comment period prior to approval, so formal action is not on today's agenda. The amendment has been advertised in the News & Advance and the public comment period is active. The Policy Board will be asked to approve this amendment at the January 16, 2020 meeting.

Recommendation: Participate in the discussion.

6. Setting Goals and Performance Measures for Connect Central Virginia 2045 Plan

Background: EPR is currently under contract to conduct CVMPO's five-year update of its LRTP, which will include elements of the Rural Long Range Plan (RLRP) and Lynchburg Connectivity Study. The process includes four milestones, each associated with completion of a planning phase. The State of the System Report (Chapter 3 of the Plan) marked the end of the first milestone. The current phase (Task 3 in the scope of work) will be completed at the end of Calendar Year 2019, once the CVMPO Policy Board officially approves the 2045 Goals and Performance Measures. Following that approval, phase three will begin and the goals and measures will be used to evaluate projects for the Long Range Plan's Constrained List of Projects, called the Constrained Long Range Plan (CLRP).



Since the 2040 LRTP update, there have been several changes to requirements, funding processes and guidelines for MPO planning. On the Federal side, recent transportation laws, such as the FAST Act changed how states and MPOs are required to evaluate projects and set targets. There are two additional Federal Planning Factors, which MPOs shall address in their LRTPs. The Federal Code also requires that states and MPOs set Transportation Targets, which CVMPO adopted in the fall of 2018. During the 2040 LRTP update, the State's new funding process was referred to as HB2 (for House Bill 2) – that funding process is now called Smart Scale. In 2015, the HB2 (Smart Scale) scoring factors were being defined while the CVMPO 2040 update was occurring. Throughout the update process, the scoring factor development was being monitored while the LRTP prioritization tool, also using scoring factors, was being developed. Since then, the State processed three rounds of the program and MPOs have become more fluent with project selection and funding applications.

Issues: With changes to codes, processes and targets, the MPO will need to re-evaluate its 2040 goals and performance measures. EPR conducted an analysis of this 2040 framework and identified opportunities for improvements, based on changes at the Federal and State levels, mentioned above. This analysis included a charted matrix that compares the 2040 Vision Themes and goals with the Federal Factors and the 2040 performance measures with Smart Scale scoring methods.

ATTACHMENT 1B

Goals: In staff's review of the 2040 goals, there is still consistency with the Federal and State guidance documents. In its review, the TTC may determine areas for improvement. Regardless of any updates, the Committee should provide guidance on how to prioritizes these goals, to help determine how performance measures should be weighted in the project evaluation process. In the review of LRTP goals, the Committee should attempt to fulfill the following objectives:

- Reflect local and regional needs and priorities,
- Reflect Federal planning factors and goals, to be consistent with enabling codes,
- Position the Central Virginia region for successful funding of transportation projects.

Performance Measures: While the 2040 goals appear to remain relevant and consistent with requirements and guidelines, there are opportunities to update the MPO's performance measures. These measures are critical to the process, as they will form the scoring methodology for ranking and selecting projects for the CLRP. An effective scoring process will help determine a prioritized project listing that not only meets local needs but is also more likely to receive funding.

Staff developed a matrix to compare MPO and Smart Scale scoring methods. In the following table, CVMPO's performance measures are on the left side, referred to as Transportation Elements in the 2040 Plan, organized by goal and vision theme. At the bottom, the table lists the State's funding criteria for any capacity building projects, which would likely be the most common funding avenue for LRTP projects. Consistency between 2040 and Smart Scale performance measures is indicated with an "x."

1. Call to Order

Turner Perrow, Chair, called the meeting to order at 4:00 pm.

RESOLUTION REAFFIRMING

THE CENTRAL VIRGINIA TRANSPORTATION PLANNING ORGANIZATION AS THE FEDERALLY DESIGNATED METROPOLITAN PLANNING ORGANIZATION FOR THE CENTRAL METROPOLITAN PLANNING AREA

Whereas the respective Boards of Supervisors of the Counties of Amherst, Bedford, and Campbell, and the City Council of the City of Lynchburg executed the Cooperative Agreement for the Creation of the Central Virginia Transportation Planning Council on September 13, 1979; and

Whereas the Governor of the Commonwealth of Virginia designated the Central Virginia Transportation Planning Council as the Metropolitan Planning Organization (MPO) for the Greater Lynchburg Transportation Study (also known as the Central Virginia Metropolitan Planning Area) on November 27, 1979; and

Whereas the respective Boards of Supervisors of the Counties of Amherst, Bedford, and Campbell, and the City Council of the City of Lynchburg rescinded the 1979 Agreement and executed a Cooperative Agreement for the Creation of the Central Virginia Metropolitan Planning Organization on or about November 16, 2000; and

Whereas since 2000, the Central Virginia Urbanized Area has been expanded to include the Town of Amherst, and the Central Virginia Metropolitan Planning Organization wishes to help increase public awareness and understanding of its mission by changing its name to the Central Virginia Transportation Planning Organization (TPO); now, therefore, be it

Resolved, that the [INSERT LOCALITY NAME]:

- 1. rescinds the Cooperative Agreement for the Creation of the Central Virginia Metropolitan Planning Organization, executed on or about November 16, 2000;
- 2. acknowledges the organization's change of name from the Central Virginia Metropolitan Planning Organization to the Central Virginia Transportation Planning Organization (TPO):
- 3. acknowledges that the TPO shall be the policy decision-making body for the purpose of carrying out the Continuing, Cooperative, and Comprehensive (3-C) transportation planning and programming process as defined in the United States Code Title 23, Section 134 and Title 49 Section 1607; and in accordance with the constitution and statutes of the Commonwealth of Virginia, particularly Title 33.2, Chapter 32 of the Code of Virginia;
- 4. acknowledges that the TPO may adopt bylaws and other rules in conformance with this Resolution as it deems necessary to govern its operation;
- 5. acknowledges that the TPO shall have such authority as prescribed in a "Memorandum of Understanding on Metropolitan Transportation Planning Responsibilities for the Central Virginia Metropolitan Planning Area" dated June 1, 2018, (as amended or updated) between the Central Virginia Metropolitan Planning Organization (now Central Virginia Transportation Planning Organization), the Commonwealth of Virginia, the Greater Lynchburg Transit Company (the primary local transit provider), and the Region 2000 Local Government Council (now Central Virginia Planning District Commission);
- 6. acknowledges that any local jurisdiction may hereafter join the TPO provided that such jurisdiction is (in accordance with state and federal regulations) included within the "cordon boundary" of the Central Virginia Metropolitan Planning Area and that it adopts and executes this resolution and is approved by the Governor; and
- 7. acknowledges that this resolution may be amended only by concurring resolution of all parties to this Resolution.
