

## Narrative of Changes to the 2021-2024 Transportation Improvement Program (Pending Public Comment and CVTPO Approval 5/19/2022)

The following Amendments and Adjustments to the FY 21-24 Central Virginia Transportation Improvement Program (CVTIP) are proposed. These program funding changes – which have been reviewed and supported by agency staff – reflect changes in program and project needs.

The Virginia Department of Transportation (VDOT) has proposed the following project amendments to reflect funding needs regarding the Route 221/501 Intersection improvements. This Amendment is within the "Urban Projects" portion of Section 3 of the CVTIP (denoted in \$1,000s).
