Specifically, the request allows for the carryover of \$44,510 to next year's UPWP to allow for the use of these funds for the Central Virginia Long Range Transportation Plan (CVLRTP) update. These funds have previously been identified for this purpose.

 Consideration of a Recommendation of Support for the Central Virginia Area Agency on Aging's, Horizon Behavioral Health's, and Heart Heavens' Federal Transit Administration (FTA) Funding Requests......Bob White, Deputy Director

The Central Virginia Area Agency on Aging (CVAAA) is requesting CVMPO support for two grant applications through the FTA. The first request is through the FTA 5310 program for capital assistance. The requested funding will be used to purchase two handicap accessible minivans and two 9-passenger vans with lift. This grant will allow for an increase and replacement of rolling stock that currently provides demand responsive transportation for elderly and disabled clients within the region. Total grant request: \$160,000; eighty percent federal funds; twenty percent Agency funds.

The second grant request is through the FTA 5317 program for operating expenses for CVAAA's New Freedom program. Funding will be used to supplement operating expenses for the transportation of disabled individuals to necessary appointments, such as medical

appointments, grocery stores, and other locations. Total cost: \$89,000; ninety percent federal funds; ten percent CVAAA funds.

Horizon Behavioral Health is requesting CVMPO support for its application for FTA 5310 grant funds. The request is for capital assistance to purchase two mini-vans with wheelchair ramps. These vehicles will be used to transport individuals with intellectual disabilities to and from home, medical appointments, work, and other community integration activities. Total cost: \$80,000; eighty percent federal share; twenty percent agency share.

Heart Havens is requesting CVMPO support for its application for FTA 5310 grant funds. The request is for capital assistance to purchase three 9-passenger vans with handicapped-accessible lifts. These vehicles will be used to transport individuals with intellectual and developmental disabilities to and from their homes. Total cost: \$105,000; eighty percent federal share; twenty percent agency share.

The Committee will be asked to recommend this item to the CVMPO.

1. Call to Order

Chairman Paul Harvey called the meeting to order at 10:30 am

2. Approval of the December 13th, 2013 Meeting Minutes

Upon the motion of Richard Metz to approve the minutes of December 12th, 2013 as presented, seconded by Don DeBerry, the meeting minutes from December 12th, 2013 were approved unanimously.

3. Discussion and Recommendation of the Central Virginia Metropolitan Planning Organization (CVMPO) Unified Planning Work Program Fiscal Year 2015 (UPWP)

Bob White provided an overview of the UPWP and reviewed with the Committee the draft plan. Bob gave brief explanations of the activities in each portion of the plan, highlighting new or interesting aspects of the plan, as well as mentioned the budgeted amounts associated with each portion of the plan.

Upon the motion of Karen Walton to approve the Unified Planning Work Program Fiscal Year 2015 (UPWP) as presented, seconded by Lee Beaumont, the UPWP FY 2015 was approved unanimously.

4. Discussion and Recommendation of the Region 2000 Local Government Council FY-2015 Rural Transportation Planning Work Program (Work Program) July 01, 2014 – June 30, 2015.

Bob White presented to the Committee brief description and overview of the Work Program and reviewed the types of activities and projects identified for the current planning year. Specifically, Bob mentioned the engagement with some localities in development and updating of their comprehensive plans, noting the transportation components.

Upon the motion of Richard Metz to recommend the Region 2000 Local Government Council FY-2015 Rural Transportation Planning Work Program to the Local Government Council as presented, seconded by Don DeBerry, this motion was approved unanimously.

5. Central Virginia Long Range Transportation Plan (CVLRTP) Year 2040 Update

Bob White presented an overview of the CVLRTP and introduced the consulting firms, EP&R and Renaissance Planning Group, who will be working on the project. Bob briefly discussed some of the differences from previous plan updates, specifically that standards of performance/measures will be incorporated and an effort made to more closely tie the Comprehensive Economic Development Strategy (CEDS) into the plan update. Bob mentioned that the TTC will be actively engaged in this plan update process.

Bill Wuensch, EP&R, and Vlad Gavrilovic, Renaissance Planning Group, together presented and overview of the plan update including the consulting team and the schedule for meetings and deliverables showing, among other things, the active involvement of the TTC. They also mentioned the requirements for the plan and also explained aspects of the plan that will be new.

Vlad Gavrilovic reviewed with the Committee new Federal and State regulations that would be affecting the plan update. Additionally, he elaborated on the performance management approach and discussed the integration of online, web-based outreach/project tools.

6. Matters from the Committee

Kelly Hitchcock mentioned a 2014 webinar series and mentioned specifics on coordinating community viewings with those interested from the localities.

Bob White mentioned that it was possible that either the Secretary of Transportation, or a representative from his office, would be speaking at the MPO meeting in April.

Bob White also discussed the need for to move the April TTC to April 11th. By consensus the Committee agreed to the April 11th date.

7. Adjournment

A motion was made by Richard Metz to adjourn, seconded by Don DeBerry, and without objection Chairman Harvey adjourned the meeting at 11:26 a.m.

The "Constrained Projects" section of the Central Virginia Long Range Transportation Plan Year 2035 shows a list of priority projects identified by the Metropolitan Planning Organization that have funding associated with them through the horizon year of the plan.

The "Vision Projects" section shows projects identified as important to the regional transportation system by the Metropolitan Planning Organization but which don't have funding associated with them through the horizon year of the plan. A transportation project must be shown in the "Constrained Projects" section in order to receive federal funding.

This amendment would reallocate the FY13 "Bus Real Estate Acquisition (STIP ID GLTC014)" funds (\$500K) to the FY14 "Bus Construction Admin/Maintenance Facility (STIP ID GLTC026)" line item. The \$500K was allotted to acquire real estate for the new transfer center but exceeded the funds needed to acquire the site. Therefore, the funds are proposed to be allocated to the construction phase of the new transfer center site. This corrective amendment supersedes the amendment regarding fund allocations in Section 4 made on January 16th, 2014.

FHWA, VDOT, CVMPO FUNDED ACTIVITIES

1.00 ADMINISTRATION

1.01 General Administration & Operations

Description: This task includes ongoing activities that ensure proper management and operation of the continuing, comprehensive, and coordinated (3-C) planning process. The objectives of this task are to implement the Fiscal Year (FY) 2014 Unified Planning Work Program (UPWP) throughout the fiscal year; provide all required administrative functions, including all accounting, personnel, contract, and office administration; and to support the activities of the Central Virginia Metropolitan Planning Organization (CVMPO) through preparation of agendas, attendance, and scheduling meetings, reports, minutes, and other duties as needed for the CVMPO board and subcommittees. Additionally, staff training is a component of this task.

Products: Efficient office operation, accurate financial information, preparation of quarterly reports and billings, as well as the various direct and indirect supporting roles to the CVMPO. A year end work summary will also be provided.

Additionally, this activity provides for staff training to enhance the transportation planning process, such as attendance at Virginia Chapter of the American Planning Association (VAPA) conferences, geographic information system (GIS) conferences, bicycle and pedestrian seminars, and other opportunities as identified. Funding for membership in the Virginia Association of Metropolitan Planning Organizations is also available.

Budget: \$42,000: staff Completion date: June 30, 2014

1.02 Work Program Administration

Description: To meet the requirements of 23 CFR Part 420 and 23 CFR Part 450, the CVMPO, in cooperation with the Virginia Department of Transportation (VDOT) and the Virginia Department of Rail and Public Transportation (DRPT), is responsible for the development of a UPWP. This UPWP describes all regional transportation planning activities anticipated in the CVMPO area, which will utilize Federal funding. The UPWP also identifies state and local matching dollars for these Federal planning programs.

Products: UPWP for FY 2015 and amendments to the FY 2014 UPWP.

Budget: \$11,000; staff Completion date: June 30, 2014

2.0 LONG RANGE TRANSPORTATON PLANNING

2.01 Long Range Transportation Plan Updates

Description: This task allows for the initiation of the update to Central Virginia Long Range Transportation Plan (Plan) as well as the review, explanation, and update of the current Plan. Consultant procurement is a element of this effort.

This task allows for staff transportation modeling development.

Additionally, this task allows for banking of funds to support the update to the Plan.

Products:

- Consultant procurement.
- Update initiation progress reporting.
- Public assistance and information, as well as preparation for any updates or amendments that is necessary.
- Banking of funds for the update.
- Staff transportation modeling skills development

Budget: \$111,407; \$30,916 staff; \$80,491 consultant (note: consultant budget amended to allow \$44,510 carryover to FY'15 UPWP)

Completion date: ongoing through FY '16

2.02 <u>Transportation Improvement Program</u>

Description: Maintenance of the Central Virginia Transportation Improvement Program (TIP), preparation of TIP amendments, and intergovernmental review of transportation projects.

Products: Approved TIP, TIP amendments, and intergovernmental review of transportation projects

Budget: \$4,000; staff Completion date: June 30, 2014

3.0 TECHNICAL ASSISTANCE

3.01 <u>General Technical Assistance (General Development and Comprehensive</u> <u>Planning)</u>

Description: This task allows for assistance to localities on transportation related activities on an individual basis or CVMPO basis, as needed. This task includes, but is not limited to, providing transportation technical input and resources to the CVMPO's localities to improve the overall effectiveness and efficiency of the transportation network; promoting improved integration of the land use and transportation planning processes; and assisting with the update of local comprehensive plans to ensure land use and other elements are consistent with the statewide transportation plan and other planning documents; and other duties as requested by VDOT, FHWA, and the CVMPO.

This task allows for the development and provision of Geographic Information System (GIS) information for use with transportation projects and planning efforts. This task also provides for the enhancement and maintenance of the CVMPO transportation component of the Local Government Council's website as well as support to the City of Lynchburg Connectivity Study.

This task will provide staff support for transportation related grant writing by member jurisdictions, such as transportation enhancement program and safe routes to school program grants, and multimodal applications

And, finally, this task will provide for flexible staff time to assist with issues that arise during the fiscal year, as well as short term projects where a locality may need assistance.

Products:

- Development and submittal of transportation related grant applications, as needed;
- Enhanced and maintained transportation component of the Coundil website to include the annual work program, Long Range Transportation Plan, Transportation Improvement Program, project data, transportation studies, meeting information, public participation plan, and related information in compliance with SAFETEA-LU;
- Assistance to localities in the development of transportation priorities for the CVMPO and region;
- Creation of GIS data and maps for transportation planning activities and grants;
- Assistance on other transportation related matters.

Budget: \$21,190; staff Completion date: June 30, 2014

3.02 Region 2000 Alternative Transportation Initiative

The following is a continuation of LGC staff efforts to continue expansion of alternative transportation planning and implementation activities in Region 2000

LGC Bike/Ped component of LGC website

Description: Staff will maintain and contribute to the dedicated section within the LGC website devoted to bicycle, pedestrian, and transit activity. Staff will be responsible for ensuring this section reflects local activities, events, and articles related to SRTS, local rides, and links to additional regional alternative transportation links (GLTS, RIDE Solutions, bike shops, etc.).

5. **Identify deficiencies and improvement opportunities**: safety, traffic control devices, lighting, clear zone/geometric, capacity (intersection and arterial), multimodal accommodations, access management, congestion reduction

6. **Conduct two public meetings** (project kickoff and then recommendations)

Product: A draft plan documenting the items identified above.

Budget: \$50,000; Consultant Completion date: June, 2014

Description: Ongoing public consultation and public participation to provide guidance in transportation planning. 44.21.00 Program Support and Administration

Description: Region 2000 Staff will assist in ongoing activities that ensure proper management and operation of a continuing, comprehensive, and coordinated (3-C) planning process. 44.22.00 General Development and Comprehensive Planning

Description: This item allows for ongoing transportation planning support services for GLTC and the CVMPO. The CVMPO will provide data gathering and analysis resources as requested and will be available to assist any regional transit agency in their planning efforts. The items in this section are geared toward increasing the safety, security, and accessibility of the transportation system to motorized and non-motorized users. The items are also meant to enhance the integration and connectivity of the transportation system. Lastly, all objectives are geared toward promoting an efficient system operation and management.

Tasks:

1. The CVMPO will be carrying out an ADA Bus Stop Accessibility Study in an effort to support GLTC's continued effort of serving the disabled population. This study will mark the first regional comprehensive ADA bus stop inventory and assessment. The

study will recognize the ongoing mobility challenges for the disabled community. The study will use analysis from the City of Lynchburg's Connectivity Study and combine it with GLTC's bus stop database in order to recognize ongoing mobility challenges for the disabled community. CVMPO staff will use inventoried features such as continuous sidewalks, curb cuts, and landing pad material to determine bus stops that are ADA accessible as well as bus stops that have the potential to become ADA accessible. Recommendations from the plan will result in prioritized improvements related to ADA accessibility and connectivity.

Budget: \$ 35,010

2. Provide the major public transit agency in our area—GLTC—with the planning assistance associated with keeping the bus stop database current. Keeping a current inventory of bus stops will promote the overall efficiency of system operations and management. This item follows on the heels of the 2012 Bus Stop Inventory in which unique identifier number stickers were placed on every stop in the GLTC fixed route system. The overall objective of this planning effort is to provide a current list of the bus stops in the Geographical Information System to improve overall transit efficiency. This item is essential in providing "Routematch"—the company that houses GLTC's bus stop data in a real-time viewing mode—with accurate information which riders can use to determine when the next bus is approaching.

Budget: \$ 15,560

3. The arrival of the new GLTC transfer center—slated to open in 2014—will require the altering of several GLTC fixed routes. GLTC is hiring consultants to conduct technical studies on the impact certain changes will have on ridership numbers and trips. Region 2000 Staff will assist the consultants in gathering information at public meetings, analyzing data and responses, and providing GIS layers when necessary. Region 2000 Staff will also create re-alignment design reports on an as needed basis. The overall objective of this planning effort is to create an up to date routing system map that can be used in a Geographic Information system. Data from every bus stop in the GLTC fixed route system will be stored at the Region 2000 offices.

Budget: \$ 23,340

4. The Transit Development Plan (TDP) developed in FY2010 has goals and objectives listed for yearly increments that need to be monitored. Region 2000 Staff will evaluate these goals and measures to assure that goals are being met in their given time frames. The overall objective of this planning effort is to ensure that the Transit Development Plan is a document that is being followed by the MPO and the various transit agencies in the region. Region 2000 staff time will be used to research existing versus future ridership, route profiles, route alignment, and service frequency and

measure their implementation against the goals and objectives set forth by the TDP. This task will lead to the overall efficiency of systems operations and management of transit in the region. This is a task that has been carried out as part of the work program for the last three years.

Budget: \$ 3,890

Basics

We are proposing to set up the project website for the CVLRTP 2040 update using a new online interactive engagement tool called **MindMixer**. MindMixer is an online public engagement tool developed by planners and in use by dozens of communities and organizations in Virginia and elsewhere. It is used by MPOs, transit agencies, DOTs and local governments among others to broaden their public outreach programs. The CVLRTP 2040 site will still work like a normal project website that posts regular information and updates about the project, but it will also have greatly enhanced capabilities for outreach and engagement of public and stakeholders in the Region. It is important to recognize that this is not a replacement for the traditional outreach tools such as public meetings and stakeholder working groups, which will still be done as part of this project, but it is a way of greatly leveraging these traditional engagement tools through an expanded web presence for the project.

Running the CVLRTP 2040 website through MindMixer will allow this project new capacity to generate ideas, gather valuable feedback and measure the impact of the Region's contributions in a productive, two-way dialogue. It will still look like the project website, fully customized with local imagery, logos and important weblinks, but it will have far more interactive power than a normal website.

This proposed approach will provide the CVMPO with strong community outreach tools that are especially relevant to the long range transportation planning update process. The core of MindMixer's interactive value rests on well-designed questions and topics for people to react to. The consultant team will develop topics and questions throughout the project for vetting and review by CVMPO staff. Topics will take different forms, such as requests for input and ideas, reactions to draft materials or short surveys, etc. Periods of activity and input on the website will be designed to leverage the input around the main three public workshops proposed for the project.

Key Points about MindMixer:

- Participants who want to post on the site must create an account before contributing, ensuring quality submissions.
- The consultants and client can monitor input and pull any inappropriate content before it is posted for public view.

- Community members can be invited to sign in through the current CVMPO or Region 2000 sites or any existing social media accounts. Participants can use existing Facebook, LinkedIn, or Google accounts or their email address to sign up to contribute comments and input.
- The consultant team will prepare initial topics and questions to get participants talking, or the client can suggest their own.
- Input can be solicited through instant feedback via poll questions or with long-form surveys to get more detail where needed (such as more detailed input on the draft plan).
- The site also allows clients to quickly check the progress of the outreach to find out how many people are engaging, and can export reports to analyze participation.

A common feature of MindMixer sites is an introductory video that is developed for the homepage by someone associated with the project that welcomes visitors to the site, introduces the project and asks for their input and continued participation. Normally, this is as simple as the project director (Bob White, for example) reading a page of text for 2-3 minutes. If this is desirable for this project, we can write up a script for this video.

• "Who's Listening" Page:

This is a standard feature of MindMixer sites and is just a listing of who will be receiving and reading the public input that is posted on the site. This helps participants relate to real people on the project side and gives a human face to a project. Typically, this would be the project director and key staff, but could also include consultants, appointed/elected officials and/or steering committee members. All that is needed is the confirmation from staff/TTC of who should be listed and photos and brief bios fopr each "who's listening" member. Suggested "who's listening" team is:

Project Overview

This LRTP update effort will build upon recent planning initiatives in Region 2000, as well as meet the needs of emerging state and federal policy and legislative changes to forge a strong transportation policy framework for the coming decades. In particular, three focus areas for this LRTP update will be:

Economic Development - Building upon recent economic development initiatives, especially the recent economic development visioning effort undertaken through the Comprehensive Economic Development Strategy (CEDS) process for the Region. One of the focus areas of this plan update will be to better link transportation policies, programs and projects to economic development and ensure that transportation funding is leveraged to support local economic development.

MAP-21 – The reauthorization of the federal transportation funding bill in 2012 (MAP-21 or Moving Ahead for Progress 21) extended federal funding support for states and MPOs and established a new performance management approach to allocating funding in the future. While some of the provisions of MAP-21 will extend beyond the time frame of this plan update, it is the goal of this update to make the

new LRTP "MAP-21 ready" and ensure that Region 2000 is both in compliance with federal provisions and is best positioned to take advantage of funding opportunities in the coming years.

Performance Based Planning & Programming – Both through the federal-level MAP-21 direction and through recent state-level initiatives (VTrans statewide transportation policy plan and House Bill 2), transportation policy and planning is increasingly being based on a performance-driven, outcome-based approach. One of the goals of this LRTP update will be to develop a clear and transparent framework for project prioritization that has broad support from the leaders in the Region. A key part of the process for this update will be to seek input and guidance on both general principles and specific criteria for how transportation projects are prioritized in the Region in the coming years.

All three of these focus areas will be incorporated into the LRTP update process, with the end result being both an overarching policy framework for transportation in the coming decades, as well as a refined list of transportation needs and projects to meet the vision, goals and objectives of the Region.

Topics:

MindMixer sites invite input through a constantly updated set of "topics" that are posted regularly on the website. Topics are questions, invitations for input or invitations to post relevant photos or videos to the website. As described above, the consultant team and/or client can review all posts on the site and pull any that may have inappropriate content before they reach the public.

A series of topics/questions for the CVLRTP 2040 site are proposed below. The initial set of topics is oriented around big picture themes, understanding values, vision and goals of the plan, and are geared toward the first public workshop. One to two new questions/topics will be rolled out each week, to keep content fresh and keep people returning to the website. Typically, we will leave topics open for a 3-4 week period, so that content and topics will stay fresh, although all old topics can be left open as well. At any given time there should be 3-7 active topics up on the site. If too many topics are rolled out or left up on the site, it can be daunting or overwhelming for visitors and may discourage participation.

Best practice with MindMixer sites is to roll in and out topics in a steady rate, a preliminary version of which is proposed below. This schedule shows how up to twelve topics could be rolled out prior to the workshop, starting with big picture values and vision affirmation and goals and ideas for the future. A similar set of content will be developed for future workshops, and the topics tailored according to each workshop's purpose.

STATEMENT OF PURPOSE Approved September 5, 2002

The Central Virginia Transportation Technical Committee (Committee) is responsible for supporting the Central Virginia Metropolitan Planning Organization's (CVMPO) and Region 2000 Regional Commission's transportation policy decision-making efforts.

The Committee provides technical advice in coordinating the federally-mandated "3-C" or continuing, comprehensive, and cooperative, transportation planning and programming process.

The Committee's three principal work efforts are updating the long range transportation plan, updating the transportation improvement program (TIP), and developing the annual unified planning work program. The Committee, in conjunction with its rural colleagues, also develops the annual Rural Transportation Planning Assistance Program Scope of Work. The Committee's intent is to review and comment on TIP projects and work program products.

The Committee acknowledges that the long range transportation plan update is the primary planning document for transportation issues in the Central Virginia region. This planning initiative drives the formulation of the transportation improvement program, as well as the annual work programs.

The Committee further realizes that the long range transportation planning process must identify regional priorities in order to fully influence project funding decisions ultimately exercised by the Commonwealth Transportation Board. The Committee's intent is to recommend priorities and encourage the CVMPO to set these priorities at the regional level.

Because of its importance, the Committee is fully committed to actively being involved in the long range transportation planning process.

In carrying out its responsibilities, the Committee will:

- 1. Coordinate with local planning departments to ensure an understanding of pertinent local development issues and their impact on the region;
- 2. Coordinate with nearby MPOs and develop an ongoing dialogue with them;
- 3. Strive to integrate land use and economic development, as well as transportation considerations, in its planning process;
- 4. Strive to be proactive as opposed to reactive in problem solving.
