From Forest Rd to Waterlick Rd
















US 29 Alternate (Western Alignment)

The MPO, which serves the Lynchburg metropolitan area, has assembled a vision list of the region's desired transportation improvement projects through the year 2040. After a thorough review, twenty one of these have been identified as "high benefit projects" that should be given top consideration for funding. The final financially-constrained project list that will be included in the Virginia Department of Transportation's (VDOT) Six Year Improvement Plan (SYIP) will be selected from this group and approved after an official 25 year funding projection is provided by the state.

As part of the project evaluation process, a preliminary environmental screening was performed for every proposed project. Seven types of sensitive environmental resources were considered during the screening. The first table in this packet provides a list of the high benefit projects, as well as a description of each project's proximity to the seven categories of resources. This letter is in response to the scoping request for the above-referenced project.

As you may know, the Department of Environmental Quality, through its Office of Environmental Impact Review (DEQ-OEIR), is responsible for coordinating Virginia's review of federal environmental documents prepared pursuant to the National Environmental Policy Act (NEPA) and responding to appropriate federal officials on behalf of the Commonwealth. Similarly, DEQ-OEIR coordinates DEQ's response for the State Environmental Review Process (SERP).

ENVIRONMENTAL REVIEW UNDER THE NATIONAL ENVIRONMENTAL POLICY ACT: PROJECT SCOPING AND AGENCY INVOLVEMENT

As you know, NEPA (PL 91-190, 1969) and its implementing regulations (Title 40, *Code of Federal Regulations*, Parts 1500-1508) require draft and final Environmental Impact Statements (EISs) for federal or federally licensed or federally funded undertakings which will or may give rise to significant impacts upon the human environment.
